This product contains essential plant oils; it is possible that Essentria® Contact Spray may mar some sensitive surfaces. This product has been tested on numerous surfaces without issues, however, always test a small non-visible area first before spraying to ensure staining will not occur. Use in and around boat docks, apartment buildings, barns, food service/handling establishments, homes, hospitals, hotels, houses, industrial buildings, kennels, kitchens, mills, motels, nursing homes, office buildings, restaurants, schools, stores, supermarkets, warehouses and similar structures.
